- All Tier-1 retailer required to integrate their POS with FBR system for submission of sale invoice on real-time basis.






- Software Data Controller will be installed locally or **on Cloud** on the same POS System/Within local Network
- Software Data Controller will become the part of the POS system



# Steps

- Customer visit the counter to pay for his/her shopping
- Counter Boy Prepare the Invoice
- Invoice is forwarded to FBR system for invoice number
- Fiscal Invoice is generated, encrypted and stored in FBR Sale Data Controller and returns a fiscal invoice number to POS.
- FBR Sale Data Controller Synchronizes the data with FBR central server on periodic basis.
- POS generate the QR Code for fiscal invoice.
- The receipt is printed out from the POS and physically delivered to the customer
- Customer receive the printed fiscal invoice and verify it from FBR System using any of proposed mode.
- On verification of invoice, FBR system mark this invoice for 6% tax collection. In case of non-verification of invoice, Bill will be changed as 9% tax collection.
- Customer pay the bill according to the applied tax.

- Real-Time Integration with FBR System
- Automatic uploading of invoice data in FBR System
- Prepopulated into Annex- C of Sales Tax Return

# How to integrate...

- FBR require following functionality to be develop in Point of Sale software
  - On the Event of Print
  - Push invoice data to Fiscal Soft Data Controller
  - On return, SDC Receive Fiscal number against each invoice
  - Print Fiscal Number, QR Code and FBR logo on Print Receipt

# How to integrate...

## POS Integration on test environment

- 1) Register for test
- 2) Download FBR Fiscal Data controller (SDC) from FBR Web Site
- 3) Install SDC on the same computer where POS is installed
- 4) Consume the Restful Web service for fiscalization process
  - Send the Invoice data to SDC
  - Receive the Fiscal Invoice Number
  - Print FBR Logo, Fiscal Number and QR Code on Print Receipt

# How to integrate

## POS Integration on production environment

- 1) Register each POS FBR Web Site
- 2) Install SDC
- 3) Update Existing POS with Fiscal Enabled POS
